- Global equity markets closed the week notably lower as the August Consumer Price Index (CPI) report exceeded expectations and sparked a sell-off in risk assets.
- Earnings came into focus with negative preannouncements from corporations lowering forecasts on cyclical weakness in the global economy.
- Yields across the maturity spectrum were higher, weighing on fixed income returns, as persistent inflation raised the likelihood of a more aggressive Fed.
- Financial markets will be focused on the upcoming Federal Reserve meeting on September 20-21st. Markets are pricing at least a 75-basis point rate hike at the meeting.
